### VIEW FROM THE HILL



Lisa Friedman, parish minister to our sister congregation in Mankato, will be speaking at Nora on February 4. (We're exchanging pulpits that Sunday, so I'll be leading the service at UUFM.) You'll want to be in church that day, for Lisa is a good soul, colleague and preacher.

Lisa's visit has me thinking about the importance of maintaining connections, as in the case of our two congregations. But there are many other kinds of connections: connections to the inner world as well as the outer, connections to the past as well as the present, connections to

family, friends, nation and world.

If my experience and observations are in any way typical, connections are not a maintenance-free proposition. To choose to be tethered to a belief requires that we remain open to new truth. To choose to be tethered to a person requires that we remain open to the inevitable changes that affect both partners. And to choose to be tethered to a group is to remain open to evolving relationships of many kinds.

February, the "month of love", is a swell time to reflect on the state of our various connections, for what are connections if not the choice to risk loving of some sort, in some way? And what is loving if not the choice to enter into the risky, blessed, aggravating business of connection?

Connections can be severed by all sorts of things: time, distance, change, truth, fear, frustration, death. Connections are fragile things. They are not a maintenance-free proposition.

I invite you to join me in reflection on the state of your connections. In my own case, I've some work to do in this area - some connections, old and new, that need more attention than I've been giving them. So, here's to our connections and the Cod who teaches and reaches us through them. May we give and receive, ever mindful of our need for one another.

#### MINISTERS TO INCARCERATED UUS

The Church of the Larger Fellowship (CLF), a cyber-space congregation providing Unitarian Universalism to isolated religious liberals, offers a 2 spiritual lifeline to incarcerated UUs.

Almost 300 prisoners across the US have joined the UU Church of the Larger Fellowship, with more every month. With no access to the web or UU Sunday services, prisoners' only way of learning more about UUism is through written publications, and letters exchanged with CLF staff and other UUs.

Sadly, dozens of CLF prisoner-members have been waiting for many months to be matched with a UU penpal through the CLFs Letter Writing Ministry. In other business, committee reports were received. The RE Committee is planning to have a monthly Children's Chapel. It also urges families to make increased effort to attend Sunday services.

#### PRESIDENT'S REPORT

On February 4th there will be a short Congregational meeting following the regular service to consider some by-law changes. As we keep growing and working we hopefully find better ways of doing some things. Some of this change is simply adapting to changing times and conditions around us. Some is just finding better ways to allow the talents in Nora to express themselves. Nora is like any living thing, if it doesn't change even in little ways, it becomes less vital. Please check out the article on the By-law Changes and call if you have any questions.

#### **BY-LAW CHANGES**

On February 4th the Board of Trustees asks that you vote on these changes to the By-Laws of Nora.

The changes are indicated by the underlined words below. These changes can be voted on as one item or the two items they break down into.

The first Item is to change the number of Trustees to seven as seen in Article III, Section 1. The fact is that most boards function just fine with seven board members. Nine board members simply ties up two more people whose work for Nora could be better spent at the committee level.

The second Item is to elect New Trustees and Officers for the coming church year in February as seen in Article III, Section 2 and Article VI, Section 2 & 5. By electing these people in February we allow them the chance to go to either Prairie Star or General Assembly to learn more about Board leadership before they take office. Also, if elected to serve as an officer they have the chance to learn from the outgoing officer. Either way we get Trustees better able to hit the ground running and with more knowledge about how to do their job.

#### ARTICLE III

Section 1. The business and general management of the church shall be by a board of Trustees consisting of <u>seven</u> members elected by and from the voting membership of the congregation. Two trustees shall (normally) be elected each year for 3 year terms. Every third year three trustees shall be elected for a 3 year term. No trustee shall serve continuously for more than two such full terms.

Section 2. As soon as practical after the <u>February Trustees</u> election, the new Board of Trustees shall meet to organize by choosing from its members the following officers: President, Vice-President, Secretary and Treasurer, for the coming church year.

#### **ARTICLE VI**

Section 2. At the Annual Meeting, full, complete and accurate reports shall be presented by each and every department of the church and a budget for the church year shall be passed.

<u>Section 5. A congregational meeting will be held the last Sunday in February for the purpose of electing trustees for the coming church year to take office in July.</u>

#### **RELIGIONS EDUCATION**



We are trying something new for the kids February through April. It is called **Children's Chapel. Chil-**

dren's Chapel will occur one Sunday a month, usually the third or fourth Sunday. All the children will go downstairs at the start of the worship service for their own service. Don will be downstairs to help with the Children's Chapel service and then will return upstairs for the remainder of the adult service. Our Children's Chapel services and following activities will be based on ideas from the Holidays and Holy Days curriculum. The RE Committee is excited about this new program. It will provide the kids an opportunity for some time with Don. They will also be involved in their own mini worship service, which we hope will be a fun learning activity for the kids.

Children's Chapel will replace RE Wednesdays. We found attendance for RE Wednesdays to be declining as the ages and interests of the children has changed over the years. The service projects that were done during RE Wednesday will be incorporated into Sunday School class time.

Thinking of service projects - the first batch of letters/pictures to our friends at our partner church (es) in Romania will be mailed soon, if not already. Pictures were taken of each of the kids kindergarten through 7th. grade. The kids have written information about themselves and/or drawn pictures that will accompany their personal pictures. They also learned a little about Romania and saw pictures of children from the partner church(es) Christmas programs. It will be fun to see where this all leads.

There a few curriculum changes for the remainder of the year. The Young'Uns and Juniors are done with learning about different Bible stories. The Young'Uns will be doing activities from the UU preschool curriculum, **Celebrating Me and My World.** The focus of this curriculum is helping the children learn more about themselves and what they can do, and how they can interact with each other and their world around them. The Juniors will continue to learn more about UU history, people and beliefs. **A Lamp in Every Corner** will be the primary source for stories for the Juniors. Activities will be drawn from a variety of resources including: **The UU Kids Book; We Believe; and My Unitarian Universalist Journey Workbook.**

#### DON'S SCHEDULE


