## A VIEW FROM THE HILL



*...I, therefore, with the authority vested in me by the church and by the state of Minnesota, acknowledge that you are Husband and Wife...*

After fifteen years it still sometimes takes my breath away. I utter those few words and sign a piece of paper--and then the legal status of two people, a man and a woman, changes. He and she who had been single are now married. And in a sense, in the eyes of the powers that be, I was instrumental in making that happen.

Now, lest I get carried away with delusions of my own power or the couple lose sight of their ultimate responsibility for the creation, care and well-being of the marriage, I always include this statement in my opening words: *Into this holy estate you two come now to be joined in a ceremony, which to be true, must be a symbol of something inner and real--a sacred union of hearts and lives, which the church may bless and the State may make legal, but which neither state nor church can create. You only may do that.*

Still, the fact remains; the state grants me, as minister, the legal authority to solemnize weddings--for some couples. For a man and a woman.

I've probably blessed nearly as many same-sex unions as I have weddings between men and women. I send the same packet of information to all couples. I ask the same questions of all couples. I personalize ceremonies for all couples. I charge the same fee for non-member couples, whether male/female or same-sex. The only difference of any significance is that I don't sign a marriage certificate for the same-sex couples--and I feel compelled, regretfully, to remind the same-sex couples that their ceremony has no legal consequences.

Marriage between two women or two men is legally recognized in just five US states; Minnesota is not one. In fact, Minnesota passed a Defense of Marriage Act (DOMA) in 1997. My Unitarian Universalist (and other progressive) colleagues take difference approaches to this issue of inequality, injustice, and discrimination. Some have refused to sign marriage certificates for any couple until they are legally able to sign marriage certificates for ALL couples. Others request that male/female couples (in lieu of a fee) make a donation to an organize fighting for marriage equality. I sign every petition or letter of protest that comes my way. And I keep on blessing the union of any couple that asks for a blessing.

February is the month for love. It's a very good time for us to live out our values (you know, inherent dignity and worth, justice, equity and compassion, those sort of things) to the end that love might know no bounds. Nothing I or our church or any state may do now or in the future will change reality. The hard, beautiful fact is love, commitment, partnership, and family find expression every day, become embodied every day in all sorts of couples--male/female, same-sex, married or partnered. Always have; always will. That's a done deal. But legal recognition will be more than the frosting on the cake. It will bring with it security, equality, safe-guards; rights and privileges now available only to male/female couples. I can't think of a better way for Unitarian Universalists to send a Valentine to all of our brothers and sisters than to speed the day of that recognition.
