A VIEW FROM THE HILL

The Great Nora Well Saga of 2011/2012 continues.



I've been drinking bottled water since summer. Darrell and Warren and I are on first name terms with the well water tester from Minnesota Department of Health. You've all seen the contaminated well postings go up and then back down again over all the church sink. And two days ago (as I write) you voted to replace the well and seal both of the old wells. We're still hoping that the old well will last through spring, that we will receive a grant for half the cost, and be able to do the work in early summer.

I grumble sometimes, when my bath water goes from orange to clear to gray and back to clear again. When I haul my whites to the laundromat. When my dishwasher didn't get dishes clean because the water softener was removed for a while. But I have nothing to complain about.

World-wide one in six people lacks access to safe drinking water. Over two million die annually in the developing world due to lack of access to safe drinking water and inadequate sanitation and poor hygiene. Women in Africa and Asia walk an average of six kilometers (almost 4 miles) to get water. As an average American I use up to 35 times more water daily than an average African family. The numbers go on and on.

I know every day, at the back of my mind, that I live an incredibly privileged life. Water is just one example. Food, medical care, education, personal safety, freedom. I've got it all, as a white, middle-class North American. This temporary water situation is an invitation for me to move the awareness of my abundant blessings from the back of my mind to the front. To transform my casual gratitude into deliberate and regular action--conserving water, passing along information, supporting organizations bring clean water to under-served areas of the world.

Lent begins this week. I think I'll give up taking my blessings for granted. What about you?

MARCH MATCH MONTH

March is a particularly good time to donate to Minnesota food shelves. Minnesota Food Share does a match on contributions received during the month. Cash donations are needed to take advantage of specials at local grocery stores. Another supplier to local food shelves is

Second Harvest, located in Maplewood. Deliveries are made monthly.

Local food shelves are the New Ulm Food Shelf at 1107 South Valley in New Ulm 56073 and the Watonwan County Food Shelf at 108 South 8th St. in St. James 56081. A box for food is located in the entryway. Items in short supply currently are canned fruit, cold and hot cereal, pudding and Jell-O. Soups and vegetables are always useful. Thanks in advance.

UPDATE INFORMATION ON THE PRAIRIE BEACON TURBINE

As of Jan 1, 2012 the turbine on Mt. Pisqua has produced over 20,000 kilowatt-hours of electricity. Power is first used by Nora Church with the excess being sent out to Alliant's energy grid. At .0792 cents, the retail rate paid by Alliant, we have produced \$1584 worth of electricity.

To this point the turbine and tower have been trouble free. It was serviced in October for \$300. This included changing the oil in the gearbox and greasing the bearings. After this it will need to be done annually.

Publicity on construction has been good and Nora has been complimented on the congregation's action.

The Nora Church board is the sole shareholder of Prairie Beacon, Inc. They have elected Mark Wiger, Pat Kunerth and Darrell Hinsman as board members. Lee Drogemuller replaced Angie Becker who resigned in September.

The project was a lot of work but at this point business activity is fairly routine involving mostly accounting. The corporation will be filing taxes this spring although it's unlikely any will be owed.

The turbine has been producing for 8 months (since April). In 2011 income received from Nora Church was \$844. and income from Alliant was \$724. Production has been consistent with projections, although it's still somewhat uncertain how our income will be affected by a full year of seasonal wind patterns. So far pay-

ments from Alliant have varied widely from just \$2.00 to \$159.00 a month (average \$90.). The church's use is more consistent in the \$70 to \$80 a month range although it has been as high as \$150 a month.

On the expense side, figures are more certain. Prairie Beacon pays \$138 per month for insurance. Tower insurance is a specialty and the premiums were not accurately figured into the pre-construction projections. Therefore this cost is more than what was anticipated. Also fixed is the monthly \$150 for interest on the remaining principal of \$56,000 . We were successful in receiving a \$20,000 USDA grant and an IRS rebate of \$23,324. The remaining loan is backed by CD's owned by Nora Church and held at Citizens Bank. Prairie Beacon pays a 2% premium over the rate the church receives. The turbine has produced the anticipated 1 and ½ times the church's use. However Prairie Beacon's main concern will be generating enough income to meet expenses on a consistent basis. If this is not the case our account balance will be reduced. Two things could favorably affect cash flow 1) increased income if the electric utility rate rises or if there is higher than anticipated production or 2) lower expenses from reducing insurance or interest expense.

We appreciate the support and interest of church members and will try to answer any questions. Prairie Beacon Board members are available to provide an update anytime.


