Minutes: Nora Board Meeting, April 16th 2025

The Nora Church Board met for its monthly meeting at the New Ulm Country Club. The meeting was attended by Sally Hanson, Vicki Sieve, Julie Peck and Lee K. Drogemuller. Nita Gilbert was absent.

Secretary's Report: A correction from the March 2025 Secretary's report should show that Sally Hanson did talk to Jeanie Hinsman regarding the status of the renting family in the Parsonage, With the correction a motion was made and seconded to accept the report as given. Motion carried.

Treasurer's report:

The Nora checking account as of 2/28/25 was \$71,198.50. Total income for the month was \$5,341.00. Expenses for the month totaled \$11,745.03. Of this total \$8,120.97 was for Repairs / Maintenance / Landscape line 305 of the Treasurer's report. (\$2,500.00 for tree trimming and \$5,000.00 for a new roof on the Jorgensen Museum.)

A CD investment bond was also purchased at a cost of \$20,014.28. A decision that the Board made at the March 2025 Board Meeting. With this the new Nora Checking Account balance is at \$44,780.19. A motion was made and seconded to accept the report as given. Motion carried.

Old Business

1. Museum Inventory List: Lee K. Drogemuller talked to an Art Professor at Bethany College in Mankato Mn who showed interest in the project and said he would try to find a student that would be willing to work on the project. He want-

ed information from Nora as to what exactly we need for the inventory and what we would be willing to compensate a student for the work. We are looking farther into these questions. I will talk to the Brown Co Historical Museum Curator to see if she has any input on a job description.

- 2. Minister: The Nora Board will contact the UUA and put our search for a ½ time minister on hold for the time being. Sally Hanson reported that she talked to Rev.Laurie Bushbaum, (Board Minutes of March, 2025) who said she would be willing to continue to work with Nora for another. Year. A motion was made and seconded to renew the contract Nora Church has with Rev. Laurie Bushbalm from July 2025 through June of 2026. Motion carried.
- 3. Jorgenson Museum: Darrell Hinsman received a bid from Dietich's Log Home Restoration, Gibbon Mn to repair the Jorgenson Museum on the Nora property. This would include re chinking the logs, replacing some logs that are going bad, and spraying the logs with a sealer. The estimate for the work is approximately \$14,000.00 if we only repaired the outside of the cabin. \$ 28,000.00 if we repaired both the inside and outside of the cabin. The price could be reduced if we did some of the work in advance and didn't replace the bad logs. Darrell has not heard back from several other contractors as of yet. Any decision to spend this kind of money would require a vote from the Church congregation, so this issue has been tabled for the time being.

New Business:

1. Hanska Area Historical Society meeting: At the first meeting of people interested in preserving Hanska area history called by Larry Harbo in April 2025 at the Hanska Comm Center it was decided to hold a second meeting, The goal of the first meeting was to see if there would be enough interest to hold a second meeting. This goal being met it was decided to hold the second meeting at Nora Social Hall, May 4th 2025. This would be after the

Church service and on a Potluck Sunday. Interested persons are invited to join Nora members for a potluck lunch, with a meeting to follow at 1:00pm. The Jorgenson Museum will also be open to the guests. Vicki Sieve will send a grapevine notice to Nora members regarding this meeting.

- 2. Nora Survey: A survey was sent to active Nora members asking for input on the future of Nora Church. As the questions were open ended there was a wide range of suggestions, comments and ideas. Vicki Sieve will summarize the comments and they will be discussed at a Church meeting in the near future.
- 3. The Board decided to publish a summary of the Board minutes and post them in the newsletter to help keep the Nora congregation aware of what is discussed at the meetings.
- 4. The Nora Annual Meeting is coming in June, With this we are going need at least one new Board member. Lee Schmitt's name was brought up, so we will ask Joy and Julie to approach him to see if he has an interest. Colleen Hokenson was also mentioned as a possible member.
- 5. Nora Budget: The Board worked on setting a budget for the coming Church year. This budget will be presented to the congregation and voted on at the next Annual meeting.

The next Board meeting will be held via Zoom, May 21st, 2025. A motion was made and seconded to adjourn the meeting. Motion carried.
