Update from the Board

The monthly meeting was held virtually Wednesday, June 18 at 7PM.

• The Treasurer's report indicated a checking account balance of \$46,151. The property tax of \$1,344 for the year was paid now that Nora is receiving rent for the parsonage. Also, the UU dues for two quarters = \$2,034. A motion was made to move money from the checking to the savings account where it would earn some interest. As treasurer, Julie will determine the amount.

• New Board member Lee Schmitt was elected at the Annual Meeting and begins serving in July.

• A new committee will be formed to address the issues for Nora Church as it faces potential closure in the upcoming years. We are looking for interested members of the congregation to join the committee which will include Board representation. It may require only a few meetings at this time. Julie Sellner volunteered following the discussion at the Annual Meeting.

• Nora website: Gil Hanson built the Nora Church website and has been the sole administrator out of his love for Nora Church and passion for computers! Besides his time and talent, Gil has also provided all of the financial obligations of our website since it's inception. The Nora Board wants to thank Gil for his long-term generosity keeping our website up-to-date and running. Future costs and subscriptions relating to the website will be transferred to Nora Church to ensure continued access.

Summary of Annual Meeting

Annual Meeting of the Nora UU Church Congregation — held JUNE 1, 2025

The meeting was called to order by president, Sally Hanson at 11:26 AM.

Thirteen active members were present and determined to be a quorum.

Reverend Laurie Bushbaum expressed her personal connection to Nora Church and looks forward to -continuing to serve the congregation in the upcoming year.

Three projects voted on by the congregation at the previous meeting were completed – new pillars on the parsonage porch, new siding on the garage and new shingles on the roof of the museum. All projects were completed within the estimated cost. The repairs to the roof in the foyer from the fallen tree limb were also completed. The insurance coverage was sufficient to have the repairs made and the foyer repainted. We are in a queue for repairs to the wind turbine, which will require a crane to take down and replace the motor and blades. Nora Church received a gift of \$20,000 specifically for repairs to the turbine.

Darrell Hinsman made a motion to increase the board authority on maintenance expenditures without congregational approval to \$10,000. The motion was seconded and approved.

The Mt. Pisqua report was approved as submitted.

Julie Peck presented the treasurer's report. Additional investments have been purchased and there is currently over \$150,000 in cash assets. The budget was approved for the upcoming church year.

The program committee has been working with Brooke to assist with booking speakers. This has been going well. We will have the same schedule of services the first and third Sundays, September – December and March – June.

There was no old business.

Lee Schmitt was elected to a board position with the end of the term for Sally Hanson. Julie Peck and Vicki Sieve were both elected for a 2nd term.

New Business:

A majority of the items in the museum have been moved to the church basement. Lee Drogemueller will start to catalog the items. A \$28,000 bid to repair the museum walls (new chinking) was discussed it was determined to be cost prohibitive.

The results of the recent survey regarding the closing of Nora Church were presented and discussed. The formation of a "closure committee" was requested to meet occasionally to discuss details about the financial needs of the cemetery for perpetual care and how to make a celebration of the closing.

Sally Hanson expressed her thanks to Darrell Hinsman, the program committee and Rev. Laurie Bushbaum for their service to the church. Sally was presented with a plant as a thank you for her service to the Board.

The meeting was adjourned at 11:59.

MT. PISQUAH CEMETERY ASSOCIATION

The Mt. Pisquah Cemetery Association was incorporated under the laws of the State of Minnesota on the 15th day of August, 1947.

The first officers of the association were Hans P. Becken, Jessie Haugen, Marvin G. Ouren, Amund Running and Gilbert Sorbel.

The present officers are Paul Kjolstad, Maynard Moe, Rikka Hanson, Elroy Wellmann and Algot Blomquist Jr.

The cemetery has been used by Nora Church ever since Nora Church was organized in 1881 and some of the markers show burials prior to that date. The earliest one is dated 1873 (Thor Smesmo). This hill is called Mount Pisquah or Pisgah, and in this name we have the only reminder of the Jesuit Missionaries who for more than one hundred years ago travelled the plains among the Indians. On this hill it is believed they built their poor shelters, from which their prayers ascended to God. Now the Jesuits and their devoted missionary work is forgotten, and only Mt. Pisquah in Brown County is one of the places which in name yet bears a faint recollection of their missionary work.

Early history tells us that the Hill was a holy place for the Indians. It served as their burial grounds prior to church ownership. When building the first church, which was destroyed by a cyclone, the remains of many Indians were unearthed, sitting on stones in a circle.

The cemetery has 1,088 plotted burial graves. As of this writing we have had 407 burials on the Hill, so Mt. Pisquah Cemetery will serve our needs for many years to come.

Mt. Pisquah Cemetery is situated on the highest point in Brown County. Its rugged beauty is complimented by the peace and tranquility of the countryside. Its exceptionally well kept grounds are indeed a very real living tribute to the untiring and inspiring efforts of our forefathers.

Our present grounds keeper, Fred Larson, at the age of 85, is starting his 40th year in that position. We are indeed indebted to Fred for his service to all of us. In recent years Fred has been joined by another dedicated worker, Algot Blomquist Jr., who assists him in caring for the church grounds and cemetery.

A flag pole, which was given in memory of the Running and Moe families in April, 1981, was a gift from Oscar and Maynard Moe. It was erected on the first church site on Mt. Pisquah.

Thirty-six pyramid arborvitae and six blue spruce trees were planted to replace all the elm trees which were lost to dutch elm disease the last few years. Paul Kjolstad, Ezra Sandmann, Maynard Moe, Elroy Wellmann and Algot Blomquist Jr. accomplished the project. Hail to the springtime of
